

#### MARCHING



## DEPARTMENT OF ENVIRONMENT

The Department of the Environment is discussing the posibility of having a new landfill near the city of Wiles in Seitz County. They are doing this because the landfill in Schragville, Missouri is full, and they are seeking a new landfill to dump into.

The Department of the Environment believes that the biggest problem is that the property value will go down and that the Prarie will be defaced. It could also destroy plants.

They also beleive, on the topic of public roads being built, that the land should be saved, as much as possible. They believe that as soon as there are enough roads to provide the city and county with, they should stop building the roads and preserve the prarie.

The Department of the Environment supports the landfill. They are also planning to have roads built for the the trucks so they can get to the dump. These roads will be available to the public when not in use by the trucks.

The department also says that when they talk to the citizens of Wiles, they will explain the pros and cons to try to gain their support. They say that the prarie will grow back and initiate technological advances to speed up the decomposition so the plants will grow back and the animals can live on the top of the hills created after the trash has gone through the decomposition process.

The Department of Commerce unveiled plans today in an interview to build a golf resort in an undisclosed county. ### PAKISTAN VS INDIA

Washington, June 6- Pakistan's nuclear arsenal is vastly superior to that of rival India, with up to five times the nuclear warheads, say U.S. military and intelligence officials now reassesing the South Asian balance of power. Senior U.S. officials have told NBC news in the past week that Pakistan not only has more warheads than its longtime adversary, but has far more capability to acctually use them. Nuclear weapons tests by India and Pakistan in May 1998 caught American intelligence off guard. While U.S. agencies have long known about weapons-development research in both countries, the decision by both to go public with their capabilities shocked policymakers. Since then, U.S. intelligence and diplomacy has focused on South Asia with a new intensity. Until recently, for instance, Pakistan was considered to have somewhere between ten and fifteen nuclear weapons and India between twenty fice and 100. But after two years of intelligence gathering, officials now believe those figures overstate the capabilities of India's home. Grown arsenal and understate those of Pakistan, whose program has relied on generous Chinese assistance. Perhaps most important, the official said, is that Pakistan appears far more capable than India of delivering nuclear payloads. American intelligence does not

Continued from page 7 (Pakistan vs India) believe that the Pakistani's have good ballistic missles. Marine Corps Gen. Anthoney Zinni, commander of the U.S. Central Command, said longtime assumptions that India had an edge in the South Asian strategis balace of power were questionable, at best. Other Military and intelligence officials, as well as an intelligence analysis of South Asia's nuclear balcance obtained by NBC News, shed more light on the revised view. "They both have capability," said one senior military official. "Pakistan's may be better than India's, with more weapons and more capability. Do not underestimate the Pakistani program. These officials believe India understands that it is behind. A recent Defense Department report said that "India announced its plans to develop a minimum nuclear deterrent force comprised of a triad of nucler delibery system-air, mobile land based lauches and sea-based platforms. The air component of its triad is the only one that may be in place already." The U.S. report also states that "India probaly has a handful of nuclear bombs,"

meaning about five. With regard to delivery system-the missles and bombers needed to launch a nucler strike--U.S. officals now believe Indian capabilities to be serioulsy lagging. According to the Defense Department document, which is unclassified, India has no nuclear-capable missiles and fewer aircraft capable of delibering a nuclear payload than Pakistan does. India has twice tested a now intermediate-ranged missile, the Agni, which may eventually probide the basis of a nuclear missile force. However, current U.S. analysis suggests the Agni will not be fielded with nuclear warheads for another 10 years. Additionally, India appears to only have begun work on missle force. You better watch out India is going to take over the world.
