## Real Senators Setting Poor Example for Staters

Senator Trent Lott sounded a call to arms last Friday, urging all Republicans to "begin to wage the war today for the election in 2002." This came as a result of Sen. James Jeffords - a former Republican from Vermont - switched his affiliation to become an Independent. His change resulted in a Democratic majority in the Senate 50-49 with one Independent.

However, not all Republicans are preparing for battle as Lott has suggested.

"I think what we've got to do is try and work out an organization resolution that both sides can be happy with, both sides think is fair, and one that'll work," said Utah Republican Orin Hatch.

With the control of the Senate in the hands of Democrats, a new push will be made for a Patient's Bill of Rights, along with an increase in minimum wage. The White House has opposed the Bill of Rights, while the increase in wages faces strong criticism from business and industries.

Despite the potential conflict on these issues and others, many senators feel this is a time for bipartisan cooperation.

"We'll be at least as cooperative with the Democrats as they

were with us last January in (post-election) reorganization," Sen. Don Nickles, the assistant Republican Leader from Oklahoma said. "I expect (the transition) will be orderly, but they're going to have to listen to us too. We have to listen to each other."

## Stormy Conditions Threaten Kansas Towns

As spring presses on, changing weather conditions continue to occur. With such huge changes every day the threat of tornadoes becomes much more real. With cities expanding rapidly, it's becoming harder to provide sirens that will warn the residents of an oncoming tornado or severe storm. In Wichita. it wouldn't be odd to see brand new houses with beautiful landscaping and decorations dotting the outskirts of town. It is this type of suburb that faces problems acquiring warnings of ominous weather. If many conditions are right, including humidity, temperature, and wind direction, then it may be possible for citizens to hear the sirens over a mile away. Otherwise many are left without warning when working outside. The main purpose of the sirens is warn those who aren't near some sort of electronic warnings. These include radios, cable TV, and even specialty radios only meant for storm and weather warnings.

With each tower costing approximately \$15,000 to buy, budgets only allow for Wichita

to place two new towers per year. In addition to buying the sirens, maintenance must also be paid. This usually runs between \$25,000 and \$30,000 a year for all of Sedgwick County, which currently encompasses 90 sirens. Along with Wichita, many other Kansas towns and cities hope to have increased budget for more sirens in order to promote the safety of their citizens.

Kathy Patry first noticed an aneurysm when it had ruptured, leading her to a hospital visit. Later that same week. Theresa had a basketball tournament she was participating in. She decided to attend and ended up scoring a basket, which she dedicated to her mother. Because of this, she was selected Most Inspirational Athlete at the Havs tournament. Theresa and her mother had been very close friends and did everything together. When Kathy died from two aneurysms in April. Theresa used sports to deal with her loss.

"I liked to be with her all the time," Theresa said. "I miss her very much. I wish she was still with me."

## Iraq Cuts Oil Exports in Response to UN Sanctions

Oil prices jumped to a fourmonth high Monday after Iraq followed through on a promise to cut all oil exports - except to neighboring Jordan and Turkey. The move was in protest to a UN decision to extend Iraq's oilfor-food program for one month instead of the usual six-month extension.

Iraq provides five percent of the world market for crude oil. To fill in the gap caused by this sudden stoppage, the Organization of Petroleum Exporting Countries (OPEC) vowed to cover the production loss by a small increase around the world.

The U.N. currently has several sanctions on Iraq stemming from the invasion of Kuwait in 1990. Subsequently, the economy of Iraq has plummeted and now depends on the food rations provided by the Iraqi government through the oil-for-food program with the U.N.

The decision to extend the program for one month was to enable the U.N. Council to examine a plan proposed by Britain, and supported by the U.S., to lift many of the sanctions on Iraq, only leaving sanctions on products that could be made into weapons. The plan would also increase security around the Iraqi border to stop oil smuggling and illegal surcharges on the oil.

Iraq does not approve of this plan and official statements made clear that the only solution they would deem reasonable would be a complete lift of all sanctions.

## McVeigh Files for a Stay of Execution

On Wednesday Federal Judge Richard Matsch will hear arguments from the government concerning a new hearing for Oklahoma City bomber Timothy McVeigh. McVeigh's defense would like to overturn the decision of the death penalty because of anything contained in the 4,400 new pages of material turned over to the defense by the FBI. McVeigh's defense team is arguing that they could not properly defend their client because they did not have access to all of the pretrial discovery materials. In their petition for a stay of execution, McVeigh's lawyers state that the government failed to turn over all of the materials to them, thus committing a fraud on the court.

In the newly uncovered documents there is an interview with Indiana seed dealer David Schafer who says he remembers discussions of a "super bomb" while on the farm of Terry Nichols in Michigan. Schafer also says he saw a diagram of what he later thought was the Oklahoma City Federal Building, Although, Schafer claims all of this, he is said to have "credibility" problems. Other documents include letters McVeigh wrote to his sister while serving in the Gulf War.

Another document is an interview between an Oklahoma City newspaper reporter and an FBI agent that says Dennis Mahon was involved in the bombing. The interview was done in connection with an FBI investigation of Mahon. The Justice Department says the interview had nothing to do with the bombing and was not filed with other Oklahoma City bombing documents. The defense claims that the government deliberately filed the interview separately to keep it from the defense. Judge Matsch has since had the materials turned

turned over to the defense, and will be hearing arguments 9 a.m. Wednesday.

## Tianamen Square Massacre Remembered

Thousands of Hong Kong rights activists are preparing for a candlelight vigil to commemorate the 12 anniversary of Beijing's June 4, 1989 crackdown on demonstrators in Tiananmen Square. The vigil is intended to remember the thousands of pro-democracy protestors killed when Chinese tanks and soldiers charged into Tiananmen Square and opened fire. The government feared that the protests would bring about social upheaval, and since the protestors would not give up, the government brought in the military. The attack, considered by many to be one of the darkest moments in Beijing history, was implemented by then Premier Li Peng, now China's parliament chief and number two in the Communist Party hierarchy.

Beijing is very eager to keep its clouded record of human rights off of the front page as it bids for the 2008 Olympics. To ensure that no attention is brought to the situation, Hong Kong authorities are detaining those they feel would participate in the commemorative activities to warn them against doing so. The authorities are also warning foreign news organizations against "illegal reporting"-which covers visits to Tiananmen Square and unap-

proved interviews. The authorities are even arresting certain dissidents and putting them under house arrest.

For years groups have protested to all of the details of the massacre revealed to the public. One of the most vocal groups has been the Tiananmen Mothers, a group comprised of 100 mothers of Square victims. In an open letter the Tiananmen mothers said, "The identity of those who bear criminal responsibility for the bloody massacre has been revealed to the public eye: their names will live forever as symbols of infamy in the annals of history." But, even after all these years and protests there has been no official inquiry into the massacre. As for the vigil itself, its attendance had dwindled in the last few years. Last years attendance was a mere 40,000 comapred to the million that showed up to the first vigil. "The feelings of a lot of people have changed in 12 years and they are no longer as passionate," Leung Yiu-chung of the Hong Kong Alliance in Support of Patriotic Democratic Movements in China, which is organizing the vigil, told Reuters. His colleague Lee Cheuk-yan was reported saying: "Many schools now avoid sensitive issues and many adults don't talk about it anv more, so we hope to get young people to understand the tragedy better."

Manning was reported to work for The Ridgefield Press in southwestern Connecticut, a real-life newspaper who was unaware of the prank. The paper has no regular movie critics and a circulation of 6,500 people.

Columbia is planning on pulling all advertisements containing Manning's statements from the public.
