Kindergarten Fire Kills 13 Toddlers

Seven boys and six girls are dead in Nanchang, China after mosquito coils caught fire and set their beds ablaze. Most of the toddlers, age three to four, died of smoke inhalation. The fire began just after midnight in the dormitory of the Jiangxi Radio and Television Arts Kindergarten. It is common for

for parents to leave their toddlers in a full-time boarding kindergarten during the week.

Chinese news reports that there were actually seventeen children sleeping in the dormitory that night. One child ran to safety, while three others were carried to safety by fire fighters. Not all of the information concerning the accident has been revealed. But, China's top government officials have visited the site, and an investigation is underway.

Jiangxi is no stranger to tragedy. On March 6, and explosion rocked the city and leveled a schoolhouse killing forty-two teachers and students. The government did an investigation and blamed the explosion on a deranged bomber. The parents of the children refused to believe this explanation, and cited that the school was making the children make fireworks, and that was what caused the explosion.

Bonds Blasts 30th Homerun

Bonds hit his 30th home run, reaching the mark faster than anyone in major league history, and the San Francisco Giants beat San Diego 3-1 Monday night for the Padres' sixth straight loss.

Estes (5-2) was pitching when Bonds reached No. 500, and was on the mound again when he reached 25 for the season against Colorado. He was there again on Monday.

"As I said the last time. I

would have felt slighted if he didn't hit me one -- and he didn't disappoint me again," Estes said.

Bonds hit No. 30 in a record 57 games. Babe Ruth reached 30 homers in 63 games in 1928.

Bonds' solo shot off Bobby J. Jones (2-8) in the fourth inning sailed over the fence in center field as the crowd chanted "Barry! Barry!"

"Barry's a professional hitter and a good one," Jones said. "I got a changeup up, and he did what good hitters are supposed to do."

Bonds did not comment after the game.

That 30th homerun marks his 524th career homerun in the majors.

Boone Has BIG Night

The highlight of Bret Boone's night wasn't his career-best seven RBI or two home runs.

It was the curtain-call standing ovation after his second homer in the seventh inning Monday night.

"You don't get that too often," said Boone, who helped the Seattle Mariners beat Texas 11-6 and extend the longest winning streak in team history to 12 games. "It gives you goose bumps."

The Mariners improved to 44-12, tied for the third-best start in major league history. The 1939 New York Yankees and the 1912 New York Giants each began 45-11.

Boone, who had his 12th and 13th homers of the season,

took over the major league lead with 64 RBI in 55 games.
Boston's Manny Ramirez and Colorado's Todd Helton each have 62 RBI.

"I know we're a heckuva team, we're playing good, I'm getting the opportunities and I'm taking advantage of them," said Boone, who was signed as a free agent this winter to try to make up for the loss of offense after Alex Rodriguez signed with Texas.

Jerry Rice, a 12-time Pro Bowl receiver for the San Francisco 49ers, is reportedly very close to signing a contract with the Oakland Raiders.

San Francisco vice-president Bill Walsh said Monday that Rice would be released from the team and that he would ultimately sign with the Oakland Raiders later in the week.

Rice, who met with reporters on Monday, declined to say he had made his final decision. He did say, though, that he had narrowed his choices to Seattle and Oakland.

According to ESPN.com, Rice will sign a four-year contract with the Raiders worth almost \$3 million over the first two years.

Rice, who is considered by many as the greatest receiver of all-time, holds the NFL records for most receptions (1,281), receiving yardage (19,247), total touchdowns (187) and consecutive games with at least one catch (225).

Letter to the Editor... Contra Skaters

In response to yesterday's editorial form the "Skaters," I felt it prudent to write up a rebuttal to several of their arguments. First of all, the Skaters show the inherent weakness of their position by resorting ad hominem attacks at the beginning of their article. As fun as name-calling might have been back in elementary school, it needs to be recognized that using it the arena of politics is always a weapon of the unprepared.

The Skater editorial made a number of contradictory statements, and I think it a good thing to recognize that these

statements were made only two dissident party members and that their opinion, erroneous as they might be, do not reflect the general sensus fidelium of either the Federalist Party or Boys' State as a whole. Among these statements are the claim that the Federalist and radically conservative" in its view. To be quite frank, these two statements cannot both be true. "Radical" is seen as being on the fringe, something that the Republican Party cannot be since it commands the respect of roughly fifty percent of the nations' voters. So if the Federalists are mirroring the Republican Party, they are not radical, but rather more towards the center, which is likely what voters will want.

Additionally, the Skaters failed to make any direct comparisons or give examples between the Republican platform and the Federalist platform, so basically all they're coming at the public with is an angry diatribe without any serious evidence or (in my own opinion) intellectual support. IN other words, it's a straw man and shouldn't be give serious heed by anyone who values themselves being swayed by argument rather than angry diatribes.

One thing I find rather humorous is that the Skater charge that the Federalists are both narrow-minded and corrupt at the same time, giving the impression that the two things go hand-in-hand. They do not, and it is indeed possible for a party to be radical without being corrupt (such as in the case of the current Reform Party) or to be corrupt without being radical

(such as with the Republican Party under Grant). Additionally. the charge of corruption is without merit seeing as how there's very little room for corruption here at Boys' State and about the only example of corruption that I can think of off-hand is the Parkinson matter currently before the courts. Of course, seeing how very few of restrain their charges of corruption until the courts make a ruling, which is why I refrain from making comments about the alleged actions of Paul Day.

As the two Federalists refrain form identifying themselves and give the general inconsistency of their editorial, I suggest discounting their information regarding Cooper Martin unless some evidence should actually surface supporting their allegations. By the way, Skaters, you say that Cooper is going to expose the Nationalist campaign plans. If you are referring to the Nationalist platform, I think that the general populace should remember that this has been public knowledge since Monday and is therefore a nonissue.

As far as which way you should vote, I won't give a speech on why the Federalists are better than the Nationalists, but listen to the debates, hear the issues, and make certain that you vote your own conscience rather than that of a popular fad or what seems cool at he time. Use you intelligence, hear the arguments, and go with whoever you thinks hold water.
