



County Press Releases

Bradley County

The commission of Bradley County has brought forth a proposal concerning three topics. The first topic discussed is that of the main highway's condition. Due to the deterioration from road salt, excess traffic, and normal wear and tear, the highway is now left in poor condition and potholes big enough to damage vehicles. With this in mind, the commission has proposed to issue a full replacement for the highway. The county will be obtaining these funds from donations from a variety of associations and departments, i.e. Department of Transportation, Association of Oil and Gas, different industries, and donations on both citywide and personal levels.

The second topic in the discussion was that of a bridge replacement. One of the county's bridges, a major bridge, has been shut down do to extremely unsafe conditions. The closing of this bridge has affected several businesses and residents. The bridge was not only a convenience, but also a major attraction for nearby businesses. Since the closing, businesses have reported sharp declines in their business. Taking this into consideration, the county will replace the bridge along with the previously mentioned highway.

MacArthur County

MacArthur County wishes to announce the proposal for the construction of a 4 lane divided highway and bridge to replace the currently overused and degraded system. Be advised to an alternate truck route around the proposed bridge.

Please be patient during the construction.

Marshall County

Existing highways- The commission has decided to refurbish the county highways at a cost of \$450. Two inches of the highway must be replaced, costing \$400, making the total adding up to \$850. The construction will take about a month and will take place at night.

New highways- There will be no need to build new highways for Marshall County. After the reconstruction of the existing highways, we believe that they will be more than sufficient for the solution to the transportation problem. Therefore, there is no need to acquire any funding for since this project is not going to take place. Looks like Marshall County is on task. Hopefully the rest of the counties are doing just as well.

Bridges- A new bridge is going to replace the one that is currently closed. It will cost \$545, and it will be a toll bridge. The toll bridge will cost 75¢ to pass, which in turn will cover the cost to construct the bridge. After the bridge is fully paid, the price will in turn decrease at a price to be determined at that time, which will go to the maintenance and upkeeping of the bridge.
