Budget Hearings

A sense of cooperation and a lack of real conflict ruled the Joint Committee meetings yesterday morning. All eight committees met yesterday and prospective budgets were tweaked and/or passed with little difficulty, leaving some Joint Committee's with extra time to look ahead to the coming legislature sessions.

The day started with a budget briefing from Governor, Mardell Maxwell, Lieutenant Governor, Andrew Winetroub, and Chief Advisor to the Governor, Dusty Johnson. After a question and answer period, the Legislature members were dismissed to their respective rooms. Upon arriving at their meeting rooms, each committee listened to different associations lobby for their own budget recommendations. The Governor and his entourage also visited the committee's, in order to give a more detailed report on their specific section of the budget.

The Governor's budget proposal was met with extreme

approval from almost all of the Joint Committees. Every group that I talked to said they only made minor adjustments to their prospective budgets. Many had nothing but praises for Governor Maxwell. Adam Hilley, the Senate Committee Chair for the Crime and Judiciary Committee said, "Especially for the time he was given, he did an amazing job." Stephen Smith from McCoy in Patton County said, "He knows what the people want already."

There were, however, some who did not agree with what the Governor was trying to do. Kelly King from King County, had this to say about the higher taxes for the wealthy. "I don't want them to pay that much (in taxes)."

After his trip to all of the Committees, Maxwell was confident in his effort to keep his budget mostly "I think we have a unchanged. really good plan and we are working hard with everyone, so I think it is being accepted pretty well," he said.

The next legislative session will be the real determining factor in how much of the proposed budget is unchanged. Each committee will present their version of their budget and the legislature will vote on it as a whole. Feel free to talk to your local committee man and maybe even lobby for you own personal interests.

President Bush met Wednesday with Israeli Prime Minister Ariel Sharon and Palestinian Prime Minister Mahmoud Abbas. summit was held in the city of Agaba, Jordan where the alleged road map for peace was discussed. The Chicago Cubs' star slugger, 17th on the career home-run list, was ejected in the first inning of Tuesday night's 3-2 win over the Tampa Bay Devil Rays, after umpires found cork in his shattered bat.

"I use that bat for batting practice," Sosa said. "It's something that I take the blame for. It's a mistake, I know that. I feel sorry. I just apologize to everybody that are embarrassed." Sosa apologized to fans, his teammates and the commissioner of baseball. His bats were confiscated by security personnel.




