Results Mixed

State's future looks a little less 'Bleeker'



The people have spoken, the ballots are tallied, the results announced, and your 2003 Boys' State officials sworn in as the State leaders for the next four days. From whatever angle you choose look at it, the Nationalists are the clear victors and the party holding the decisive mandate as Boys' State rolls through the rest of the week. Fresh from their respective victories, the candidates offered the following comments about the campaign and the work that lies ahead.

Federalist Eric Buell will hold the Commissioner of Insurance post for the 66th edition of Boys' State. And while Buell did run unopposed in the general election, this is not to imply a lack of preparedness, ability, or competency for the position. Buell elaborated by sharing his plans for office, "My first order of business is to begin attracting new insurance companies to increase competition and decrease the cost of insurance". Taking the precarious current status of insurance in the state into consideration, best of luck to Buell in his efforts.

Nationalist Wade Walker was elected to the Treasury's post. Overcoming Hooker's masterful "I

have a plan, I just don't know what it is" position in the debate, Walker got the ball rolling for the Nationalists in this afternoon's debate and translated his debate prowess into a secured state office. Said Walker of his initial plans for action, "My first order of business is to get together a state wide program



for education and highways". He went on to note that he believed his superiority in the election stemmed from the fact that he is a "man of my word, and I know what needs to be done".

Bradley Cox, the lone Federalist to survive bipartisan competition in the generals, will serve as this year's Secretary of State. Voters evidently decided to "put a check in the box for Brad Cox", and

Cox said he believed it was because, "I'm straight up with people, and I just hope that's what they want to hear" and said that as his initial order of business he would, "create a disaster plan".

After a series of badly misplayed answers by Federalist Attorney General candidate Kevin Mullinix, Nationalist Keithley Lake took advantage and put his own stamp on the debate en route to his election as state Attorney General. Lake says that to begin his term, he would like to, "Begin prison reform and get more funding for education".

Finally, taking it's place as the crown jewel of the general elections, the governor was announced, and that person proved to be Nationalist Mardell Maxwell. In a purported landslide the Pershing County native put the proverbial "icing on the cake" for the Nationalist party. As for his first order of business, Maxwell concisely mentioned that he aims to "stabilize the state". Despite the 60-40 party split in favor of the Federalist party, it's clear that the Nationalists were able to make their voices heard across party lines and voice their message through able, appealing candidates. state offices locked in, it's time to sit back and watch which direction the Nationalists steer this year's government.

Maxwell K.O.'s Bleeker in Debate

The Debate for state executive positions was the proverbial "nail in the coffin" for the Federalists and especially Federalist G u b e r n a t o r i a l hopeful, Casey Bleeker. The

The program was opened with a five minute long KSU plug. Following that, the candidates were asked two questions, given one minute to respond, their opponent was then given another minute to respond, then each was given thirty seconds of rebuttal time. The highlight of the whole debate was most definitely the gubernatorial debate. This section of the program was structured a bit differently. The candidates were asked a total of four questions and then they were given the same amount of time for response and rebuttal.

During the middle of some of his speeches and at the end of all of them, Maxwell was given a rousing ovation. The biggest ovation came after a statement Maxwell made in one of his rebuttal speeches. Bleeker had just accused Maxwell of having conservative views on many subjects. In response, Maxwell stated that the primaries were the previous day and he also said that, "Today's election is about who is the better leader." This elicited a standing ovation from many and at least applause from most. When asked how he felt about the impact of the debate on the outcome of the election, Maxwell responded, "I think

the debate was really important, because it was the last chance for the people to see our views."

On the other side were the more "conservative" speeches of Casey Bleeker. Casey did receive applause

from many at the end of most of his speeches, but nothing came close to the decibel level reached after Maxwell's speeches. The most Bleeker ever received in the middle of his speeches was some mumbles and grumbles when he quoted George Orwell's fictional book about where he thought the world was headed in the early 20th century. Bleeker even went so far as to call some crimes "thought crime." Despite the lack of enthusiasm, Bleeker was hopeful after the debate. "The crowd was a little unresponsive. I hope that it is because conservatives are just that much more conservative," said Bleeker.

There was a lighter side to the debate also. Nationalist candidate for Secretary of State, William Pruet, proposed a theme park called "Nut World." Nut World, featuring Stevie Squirrel and Stacey Squirrelette, was Pruet's answer to how he was going to draw tourism to the state.

The debate today seemed to sway many Federalists to vote for the Nationalists. Michael Popelka from Lane City in Marshall County expressed the feelings of many Federalist's. He said, "I liked some of the candidates from the other party. They were more prepared."

Election Scandal

Another lawsuit will be filed today, but this is not the same type of frivolous lawsuit that we have all grown used to here at Boys' State, especially those of us at the newspaper. This lawsuit is actually legitimate in the eyes of many Staters. Craig Kearney is suing for compensation from the state after his name was mistakenly excluded from the Federalist Secretary of State primary ballot.

Kearney and his attorneys, Josh Tario and Kelly Williams, both of Lane City in Marshall County, spent all morning yesterday petitioning associations, city councils, county commissions, and individual staters, just trying to get their story out.

Their story is as follows. Kearney accepted the nomination from the Marshall County Federalists to run for Secretary of State in the primary elections. He, just like all the other primary candidates, campaigned Sunday Security for the State of Kansas.

The Association of AntiTerrorist Security for the State of Kansas,
or A.A.T.S.S.K. for short, was founded
by Tony Joseph Sasastizado of Haney in
Kennedy County. His co-founders include:

Kennedy County. His co-founders include: Michael Donald (Finnly, Kennedy), Nathan Waller (Chastain, Eisenhower), and John Waller (Aylward, Bradley).

The A.A.T.S.S.K. was created "To promote anti-terrorist security throughout the state of Kansas. To work with state agencies to solve terrorist concerns and problems, and possible terrorist targets. To protect American culture, life style, heritage, ideals, and the American way of life;" according to the A.A.T.S.S.K.'s mission statement.

This new association has many views. In fact, it appears that this association has a view on everything. They have a view on education, minority & religion, economy, health,

night and participated in the Whistle Stop Tour. However, there was a computer error and Kearny along with some other candidates, including Federalist primary winner. Brad Cox were left off the ballot. A new ballot was made with the excluded candidates included, except Kearney was listed under Commissioner of Insurance instead of Secretary of State, the office he was running for. By the time the mistake was noticed, it was too late. Kearny is suing the state for monetary compensation only, realizing that a revote would be impossible. "I'm not asking for my position back, I just want compensation," Kearney said. Kearney and his attorneys are now waiting until all of the state's elected officials are in place and have established a budget before they decide on a dollar amount and file suit.

After his support drive yesterday morning, Kearney felt very good about his success in gaining support from local governments and associations in order to add some clout behind his suit. Nearly every group that he and his layers visited expressed support. Some even offered to help fund his cause.

Two of the biggest proponents of the cause are Kearney's home county, Marshall and the Lane City Council. "The county commission is very eager to support us," said primary counsel, Josh

However, they are not the only association that has been created. Staters' Union has caught wind of the fact that there are a few other associations in the wood works. Tario. The Marshall county commission verified their full support of Kearney and his suit and offered monetary support if needed, as did the Lane City Council. Other big-name backers included the Heritage Association and the Association of Cities and Counties. The Federalist precinct committee chairman was unable to offer comment because of a pending Supreme Court nomination.

When asked what exactly happened, Marshall County Counselor, Casey McBride, replied, "We really haven't got to the bottom of it to figure out what caused the error." "Don't blame us counselors," added Lane City Counselor, Brian Shea, "It's a small mistake, it happens every year and the people can get money out of it."

There were some who thought that the suit was unjustified. Federalist Gubernatorial Candidate, Casey Bleeker, had this to say. "You can't get a monetary fund for what it is worth. He should sue for re-election, but since it is only a weeklong mock-up, he can't. He shouldn't sue the state."

No matter what side of the issue the people interviewed were on, they all considered the mistake a tough break for Kearney. The level of sympathy and agreement with his case is what really separated the different groups.



Attention Kennedy county citizens!

The County Commission needs your help to pass this proposal to rebuild highways and bridges. We need your votes and donations to make this possible. Thanks to those who have already donated and vote yes on this proposal.

Seitz County has proposed to replace one of the old bridges with a new one and fix the entire highway, except for one section that needs replaced. We will be putting tollbooths on the bridge and highway to help pay and we will apply for bonds. Please support our highway construction.

MacArthur County Commission would like to address the people of Jardon, Janssen, and Icenogle. The people of MacArthur County will be voting on the County Highway Plan on Friday. The County Highway Plan consists of a new toll bridge, replacement of a two-inch strip of heavily damaged highway, and a new statewide highway system. The Industrial Association will pay for the bridge. The county will pay for the replacement of the strip of highway. The exact expense of the statewide highway system is currently unknown. When these expenses are determined, they will also be paid in part by they county.

Marshall County Commission has proposed to its citizens the building of a new 2 lane highway and paved road. We had also proposed the rebuilding of a bridge and making it into a toll bridge.

The two-lane highway will split the city of Klassen for 1/3 of the city. After the highway, our paved road will continue south through the rest of Klassen and split the cities of Lane and Kyle.

Our two-lane highway will cost \$200 for the 1/3 of Klassen and the paved road will total \$375 to be built into the other cities. The toll bridge will total \$545 and will be placed on the north side of our two-lane highway. The proposal totals to be \$1120.00.
