Some surprising evidence was brought up against the members of the district court of Seitz

Marshall County has filled up its mental hospital facilities. That's right, they're facilities are completely booked. The short term mental illness patients must travel to MacArthur County and stay in a long term mental hospital for more time than they require for healing.

The Coalition of Cities and Counties (CCC) and all the cities from Marshall and MacArthur Counties lobbied before the Department of Health. One spokesman

from each team would be allowed in the room to speak. The presentation included a plan to fix the problem and a plan to acquire the funds needed.

Lane City started, but had no definite plan. They did, however, mention that their city had sufficient funds to help pay the cost. Kyle City then came in and talked about a new health center they had built, which did not pertain to the situation at The representative quickly recovered changed his plans. Klassen City walked in next and got right to the point. They had neither the land nor the funds to create the new hospital.

Johnson City proposed a remodeling of the long term mental hospital, but the department shot that idea down. Janssen then entered (17 minutes late) and offered the best plan vet. Not only did they have an official estimate for the price, but they could provide land by rezoning a lot. The hospital would cost \$1,940, and the rezoning an estimated \$700. The Department of Health loved the idea.

The CCC offered a different plan by proposing downsizing the long term mental hospital and upsizing the short term hospital. After a little debate, the department decided against it. In the end, the same problem would end up occurring, only in a different way. However, the CCC was impressed by the Department of Health's dedication One member said to the department, "You're the only serious department. You're at least trying to be something." The department humbly accepted the compliment.

Icenogle City presented last and suggested a halfway house add-on to the current hospital.



really need to pick that up..." Yet, I was tired so I left it.


